# An Army of Volunteers, Loyal Small DonorsWill Protect Him from Lobbyists, Jeff Smith Says

"I'm proud that so many volunteers and countless small donations made it possible that I don't have to listen to lobbyists," said Missouri State Senator-Elect Jeff Smith at Missourians for Single Payer's opening lecture Sept. 21 at the University City Library.

Smith will represent St. Louis City's large 4<sup>th</sup> District, which stretches from north to south St. Louis City. He won over four other Democrats in the primary campaign, and is unopposed in the Nov. 7 general election.

Smith's a longtime backer of single-payer healthcare. His pound-the-pavement campaign was a novelty in an age of endless TV ads and endorsements. He made hundreds of home visits and personal phone calls to voters who had rarely seen or heard from a candidate in person.

Adding hundreds of door-to-door trips by eager college students and other volunteers creates bonds with voters, Smith said.

"All grassroots voters want is to see you face-toface for 60 seconds and hear in plain words what you stand for," he said. Avoiding slogans (e.g. "no child left behind"), he stressed universal healthcare; increasing the minimum wage and giving public schools more teachers and enriched curriculums.

He gave his cell phone number to residents who doubted they'd hear from him again; his young volunteers helped clear debris after the big storm.

Among voters he won't forget:

- ♦ An 80-year-old widow from the North Side who phoned him the day after his visit to her. "Well, hello...I just wanted to see if you were telling the truth!" she said, when he answered her call.
- ♦ Another elderly woman from Webster Groves who sent him \$5 each month for his campaign. Smith's

thank-you notes prompted her to mail him three stamps, with a note: "Don't waste your money!"

"Those are the people I'm going to listen to when I'm in office," Smith said.

After visits with many Missouri residents without health insurance, he said: "I feel that I know what reality is for many of us. I've been without health insurance, too. And I've waited in a crowded clinic with a serious hand injury before I was treated."

Smith wants other legislators "to see for themselves all the citizens who wait in pain in our jammed ERs and clinics. "If we took the trouble to do this, we'd all fight hard for single payer health care in Missouri."

A political science adjunct professor at Washington University, Smith also taught government and public policy at Dartmouth College and the University of Missouri-St. Louis. He lost his 2004 race for United States Congress to U.S. Rep. Russ Carnahan; the vote was close because Smith won both St. Louis and St. Louis County.

The 2004 campaign by Smith is the focus of the documentary, *Can Mr. Smith Get to Washington Anymore?* It was featured for many weeks at the Tivoli Theater in University City, and is currently playing in Washington, DC and Atlanta.

#### Legislation Report, Fall 2006

Congressman Conyer's bill, **HR 676, "Expanded and Improved Medicare for All"** has 77 congressional cosponsors. 191 union organizations, including 44 Central Labor Councils and Area Labor Federations and 11 state AFL-CIOs (KY, PA, CT, OH, DE, ND,WA, SC, WY, VT & FL) have endorsed **HR 676**.

On June 7 (6/7/6) MOSP launched our statewide City-by-City Campaign to endorse national universal single payer health care and urge our elected officials to pass it. The foundation of the City-by-City Campaign is the Democratic process, ordinary citizens building working relationships with their elected representatives. MOSP congratulates MOSP members who have met with their city council members over the summer: Janet Noble and Teri Williams in Webster Groves, Elsa Mutrux in Clayton, Anne Bader in Frontenac, Arlene Nickels and Robert Recht in Creve Coeur, and Martha Scheer in Kirkwood. An outline of how the city campaign works can be found at www.healthcare-now.org under the tab, "take action" and "how to draft a resolution".

After the November elections, MOSP members will be working in St. Louis County for a County Resolution to endorse **HR 676**. Two counties which have endorsed **HR 676** with a resolution are Lorain County, Ohio and Warren County, Tennessee.

MOSP has joined with Healthcare Now to "Elect a Healthy Congress". Our new buttons read "Health Care Voter". Wear the buttons, start or continue the dialogue, and work for single payer health care for all citizens. 2006 is an election year remarkable in the large number of single payer candidates running for office. Thank them for working in behalf of health care for all, and join their campaign teams to help elect a healthy congress and a healthy state legislature.

# Rated D-minus: Advantra Health Insurance Plan 'D'

I was going out of town. One of my prescriptions needed a refill to last me throughout my absence. I called the pharmacy and was told that Advantra wouldn't allow a refill in advance. I had been with Advantra about 15 years and they had never refused refills before. I paid the full price since I MUST take the medication every morning. It was not expensive, only \$11.83 out of which I normally would pay \$5.00 copay. The price is not important.

What is important is the matter of principle: Health Insurance plan D to be available to the participants. I have been a premium paying member of this insurance plan. The Caremark, a company I have not dealt with, sent me a check for 83 cents. The difference between what I paid and what I

should have paid (copay) was \$5.83. I spent over an hour talking on the phone to five persons, including two supervisors, to rectify this. A brick wall! 83 cents? I say STUFF IT!

Health insurance companies are dangerous to your health.
