# MoSP's Opening Lecture for 2007-8 Meetings


Rev. Larry Rice, Advocate for the Poor & Homeless, Will Speak at Ethical Society, 7 p.m. on Sept. 20

Rev. Larry Rice, nationally known advocate for the homeless, will give a lecture "Speak Up or Be a Victim!" on Thursday, 7 p.m., September 20, at the Ethical Society of St. Louis, 9001 Clayton Rd.

He's founder and director of The New Life Evangelistic Center in St. Louis, a downtown haven for the homeless.

Sponsored by Missourians for Single Payer Health Care (MoSP), the lecture opens the group's 2007-2008 series of meetings. It will follow a business meeting at 6:30 p.m. in the Society's main auditorium, 9001 Clayton Road.

Rev. Rice is renowned for his battles with the 'Powers That Be.' One is a struggle over the site of his proposed homeless shelter near the old Kiel Auditorium. Others want a parking garage at the location.



He also founded the "Here's Help Network" of TV and radio stations which are run by once-homeless people. The network's flagship is KNLC-TV 24 in St. Louis. In addition, Rev. Rice is upgrading seven TV stations from low power- to medium power. They are located in Missouri, Illinois and Arkansas.

Most recently he founded – and directs – the "Missouri Renewable Energy" centers. They teach alternatives to fossil-based fuels, such as solar power, wind power and recycled vegetable oils. The centers are located in St. Louis, New Bloomfield and Marshfield (website: <a href="https://www.more/energy.org">www.more/energy.org</a>.)

Other projects include a medical clinic and Rev. Rice's longtime program to provide food for residents, and help in paying their rent and utility bills. He was named "ABC's Person of the Week" and selected as "USA Today Newsmaker." His other honors include the Dr. Martin Luther King, Jr. Award and the Distinguished Christian Service and Social Work Award, given annually by a national Christian social workers' organization.

Donations of canned foods are in urgent need at the New Life Center, 1411 Locust Street. All canned goods, especially vegetables and high protein legumes, are welcome. You may bring canned goods to Nov. 20's opening program for delivery to the center.

# MoSP Summer Legislative Report -2007

MOSP's summer activities revolved around the *SiCKO*. sneak preview and premiere. Since then, the insurance companies have revved up the anti-single payer rhetoric. We must continue to write letters to the editor to all news services that print lies about *SiCKO*., health care, or single payer. Even though the solution to our national health care crisis is HR 676, we must also fight for our state single payer bill in the atmosphere of forced mandatory insurance, such as the Massachusetts Plan. Missouri becomes the first state to end Medicaid May 1, 2008.

#### State of the Federal Single Payer Bill: HR 676

Congressman Conyers' national single payer bill, HR 676, "Expanded and Improved Medicare for All" has 75 congressional cosponsors. Congressman Wm. Lacy Clay is the only member of Missouri's congressional delegation to cosponsor. It is imperative that constituents continue to write, phone and visit the other Missouri congresspersons to urge them to cosponsor and work for the passage of HR 676.

HR 676 has been endorsed by 297 union organizations in 43 states. Union groups include 81 Central Labor Councils, Area Labor Federations and 20 AFL-CIO state organizations — including Missouri's. The Missouri AFL-CIO represents 500,000 members of 391 unions in the state.

The Missouri state legislature has resolutions to endorse HR 676: HCR 23 (Mott Oxford) with 27 cosponsors, and SCR 23 (Bray) with 7 cosponsors. The resolutions were heard in the Senate Rules, Joint Rules, Resolutions, and Ethics Committee on 3/14/07. This was not voted out of committee, stifling floor debate.

The state single payer bill is the Missouri Universal Health Assurance Act. In 2007, state Rep. Craig Bland of Kansas City failed to file the House bill. SB 122 was introduced by state Sen. Joan Bray of St. Louis. SB 122 was

Mental Health Committee on 1/30/07. Twenty people testified in favor of its passage. This was not voted out of committee, stifling floor debate. State Sen. Charlie Shields of Kansas City substituted the state single payer bill for a bill for a study, which essentially erased the original bill from the senate bills. This is the first year since 1990 that Missouri has not had a single payer bill on record.
