We are all being bombarded with organizations asking us to sign petitions supporting this or that universal health care scheme. How does one decide if the plan is real or simply a plan designed to perpetuate the status quo? We all know what the status quo has done for us. Skyrocketing costs of insurance and out of pocket health care expenses have left more Americans bankrupt than from any other cause. Our poor suffer more and die younger.

Beware of the latest so-called "reform campaign" designed by America's Health Insurance Plans (AHIP). AHIP is the driving force and the funding source for Health Care for America Now. This coalition does not end the practice of insurance companies maximizing profits through denials and delays of care.

Join Team Medicare!


Join our team to work for H.R. 676, Expanded and Improved Medicare for All. The most efficient, fair,

and sustainable system of funding health care already exists right here the USA. By "expanding" Medicare to include all of us, the single risk pool of 300 million Americans enables us to decrease the costs of illness for all of us. By "improving" Medicare to include all necessary health care within our private delivery system, we will become a healthier nation.

Nationwide, single payer advocates held rallies and events on July 30, the 43rd birthday of Medicare. In Missouri, MOSP members met with Congressman Lacy Clay, one of Missouri's Congressional cosponsors of H.R. 676, via a videoconference. From Washington, DC, Congressman Clay cheered our work for Medicare for All, while his staffers, Edwilla Massey and Steve Englehardt shared birthday cake with us in his North county office. Esther and Jim Clark, Helen Schlarmann, Pat McHugh, Stephanie Brot, Bob Reinhold, James Hoggard, Roger Signor and I joined with MOSP President Julia Lamborn to mark the historic day.

H.R. 676 remains the most affordable universal health care program. H.R. 676 is endorsed by 470 union organizations in 49 states including 116 Central Labor Councils and Area Labor Federations and 39 state AFL-CIO's. International/national unions endorsing it are USW, UAW, NEA, ILWU, NALC, IAM, UA (plumbers and pipe fitters), AFM (musicians), UE, CAN/NNOC, SMWIA, IFPTE, OPEIU, UTU, SEIU, AFT, AFSCME, CSEA, (California School Employees Association), UWUA, and CWA.

U.S. Medicare is "made in America". With ninety-three Congressional Cosponsors, H.R. 676 is likely the most popular and politically strong universal health programs ever introduced. Join with MOSP and the aforementioned organizations to work for its passage.


