# Letter to the Editor, published in the St. Louis Post-Dispatch, January, 2014

When I read the editorial by Kathleen Sebelius ("A happy, healthy new year," Jan. 1), my first thought was, she's been nipping at the holiday eggnog. It sounded almost boozy as she asserted that "today is a new day in health care for millions ... throughout Missouri."

The fact is that for every Missourian who enrolls in an insurance plan for the first time, there are hundreds who don't qualify because of a pre-existing condition: they're too poor to afford the plan. And they don't qualify for subsidies because our legislators did not expand Medicaid coverage, a linchpin of the Affordable Care Act (ACA). Too bad Sebelius wasn't passing the eggnog around to the legislators in Jefferson City.

In the cold light of day, Sebelius' optimism sounds ludicrous.

The ACA rests on an icy slope of for-profit insurers whose goal is to line their own pockets. Furthermore, it cements the separation in health care doled out to the poor versus what the wealthier receive. Because of all the profits to be made in health care, we still have a precarious array of multiple insurers with multiple plans. What we need a single-payer plan that rests solidly on one insurer, the Federal government, whose goal is to pay for care, not to turn a profit. A single payer plan would include everyone — no pre-existing conditions apply — and would cover all of us cradle to grave. That would indeed give strength and real meaning to a wish for everyone to have a healthy year.

#### Health Care in the Industrial World

"Health Care in the Industrialized World" the topic discussed by Alan Ranford was MoSP's first program of 2014. "Reading "The Healing of America", by T.R. Reid, and Dr. Quentin Young's "Everybody in, Nobody out" and further study has made me realize the profound inequities in our health care system." says Ranford. "When we compare the health of our nation to that of other industrialized nations, it becomes obvious that our system is inefficient and unfair."

Ranford proposes a commission, with experts such as William Hsiao, to study and evaluate the systems that have worked for other countries. Hsiao, a Profes-

sor of Economics at the Harvard School of Public Health, author of "Getting Health Care Right" has been employed by a number of countries to advise them in forming their health care systems. Hsiao has been involved in shaping Vermont's new single payer health care law. "Professor Hsiao believes that before you can set up a health care system for any country, you first have to know the country's basic ethical values," commented Ranford. "If the nation decides that all of their people have a basic right to health care, then a system can be designed so that each person gets the appropriate medical care. If this right is not valued, then medicine is just another economic commodity based on an individual's ability to pay.

"This country is split between these two philosophies. Many people are making too much money in the insurance and health care businesses. These people have a powerful influence on our Congress.

Obamacare may be all we can expect for the present. We can continue to voice our concerns, work to educate the people and keep up the pressure on the Government. We must maintain faith that Single Payer will eventually become a reality."



# Julia's Life and career before single payer

#### Hello, Goodbye, Julia

When Julia was diagnosed with aplastic anemia, a blood disorder in which bone marrow stops making blood cells, there was only one possible cure, a bone marrow transplant from an anonymous donor. In order to prevent rejection of the donor marrow, she had to first be irradiated, and then receive chemotherapy to kill her own bone marrow.

Close friends Pat Singley, Carolyn Dawson, and I waited with her in her hospital room for the arrival of the donor marrow on the evening of August 14, 2012. We all fell silent as the nurse brought in the donor marrow. It was pink in color, opaque, similar in appearance to platelets, encased in a see-through infusion bag. Curious, Julia held the bag of marrow, examining it, and then held it to her heart, as if willing it to be the life-saving cure she needed. The infusion took a short period of time while Julia, pre-medicated, slept peacefully. The new bone marrow began making blood cells, and Julia gradually recovered her strength. She was eventually able to walk, drive a car, go out to lunch, and even preside over MoSP's 2013 Health Care Weekend events.

Julia beat the odds, and cheated death for over a year. She was so grateful to everyone who helped give her that chance. On December 25, 2013 with Pat, Carolyn and I holding her hands, her favorite cooking channel on TV in the background, she smiled, thinking about her wonderful dogs. She succumbed to pneumonia, and slept peacefully.
